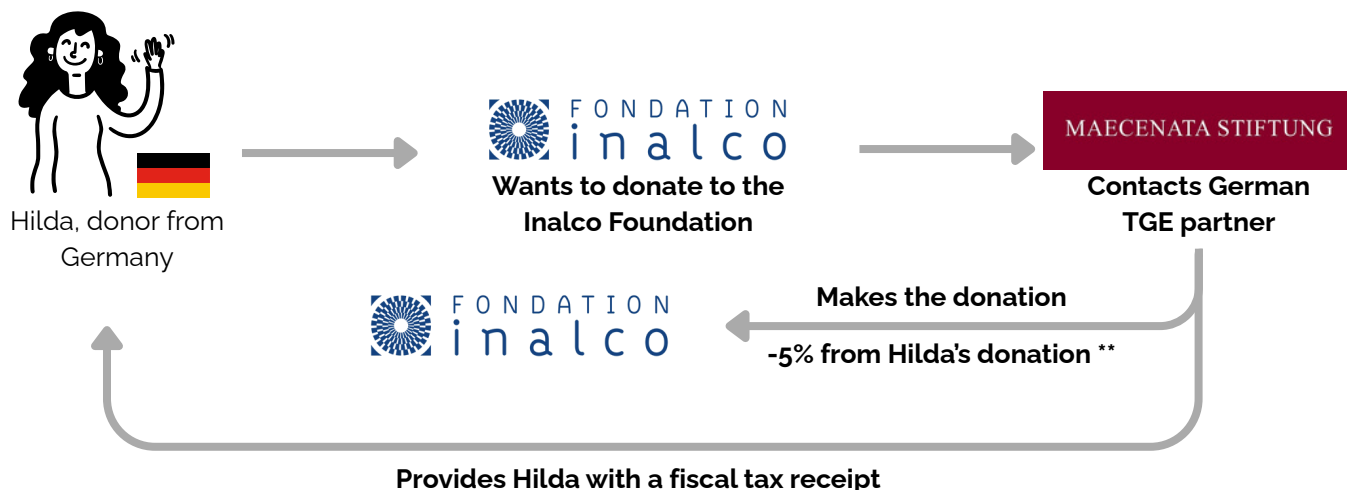
How ?

- 1 Contact the partner foundation in your country of residence
- 2 Your national foundation will establish contact with the beneficiary organisation and the foundation in the recipient country to inform them of the incoming donation
- 3 If the evaluation is positive, you can make the gift to your home-country foundation which then provides you with a tax receipt and transfers the gift to the beneficiary organisation.
